

LONDON GROVE TOWNSHIP

ORDINANCE NO. 208

AN ORDINANCE OF LONDON GROVE TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA, AMENDING ORDINANCE 98 OF LONDON GROVE TOWNSHIP BY AMENDING SECTION 1(a), DELETING SECTIONS 1(b), 1(d) and 1(g) AND INSERTING A NEW SECTION 1(e)

BE IT ENACTED and ORDAINED by the Board of Supervisors of the Township of London Grove, Chester County, Pennsylvania, and it is hereby enacted and ordained that:

SECTION 1: Ordinance 98 of London Grove Township is hereby amended by deleting Section 1(a) in its entirety and replacing it with the following:

- a. *The Tax Collector shall be entitled to collect \$2.75 per bill, excluding postage, for every Real Property Tax Bill that is processed and mailed to Township residents. This fee shall include the Tax Collector's costs of printing, folding, inserting, mailing, payment processing, fund transferring, reporting and responding to billing inquiries.*

SECTION 2: Ordinance 98 of London Grove Township is hereby amended by deleting Sections 1(b), 1(d) and 1(g) in their entirety and re-lettering the remaining subsections of Section 1 accordingly.

SECTION 3: Ordinance 98 of London Grove Township is hereby amended by adding a new Section 1(e) as follows:

- e. *The Township shall provide, or shall reimburse the Tax Collector for the supplies necessary to allow the Tax Collector to prepare and send the Township's Real Property Tax bills and the Chatham Light Fee bills, including but not limited to, any necessary software packages, paper, supplies and envelopes.*

SECTION 4: If any sentence, clause, or section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Board of Supervisors that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not included herein.


SECTION 5: All ordinances or parts of ordinances inconsistent herewith are hereby repealed.


