2018 Preliminary Budget Review

Asphalt Paver

Mr. Scott-Harper announced to the Board that with the direction of the Board Mr. Kinsey has been able to locate a small asphalt paver for a reasonable price as requested. Mr. Kinsey stated that he has inspected this paver and discussed its condition at length with representatives. It appears to be in good condition for its age and hours. The Board of Supervisors participated in a discussion with Mr. Kinsey and Mr. Battin regarding this machine and what process needs to happen now.

Mr. Szakas made a motion authorizing Mr. Kinsey to bid a used 2007 or newer Leeboy 7000 asphalt paver in good operational condition as determined by the Director of Public Works, with under 4,000 hours, legend screed, grade control, automatic flow control with sonic augers, and 2 included "easy-slates", seconded by Mr. Pickel and approved by a vote of 4-0.

Ms. Guenther, Mr. Kinsey and Mr. Battin continue to review the Preliminary 2018 Budget with the Board of Supervisors and discuss any questions that arise from the conversation. Mr. Scott-Harper announced that the 2018 Preliminary Budget that was presented this evening is a balanced budget.

Mr. Scott-Harper announced that the Board will be having an Executive Session following this meeting.
