**X: Fire and Life Safety- Fire Suppression System Permits and Plan Reviews**

Fire Suppression Systems, to include but not limited to: Fire Sprinklers, Wet Chemical Systems, Dry Chemical Systems and Gaseous Suppression Systems must have appropriate plans, calculations and cut sheets provided with the application for a permit. **Three sets of plans are required with the submission.**

Section 3: Insurance Requirements:

Before Building, Plumbing, Electrical or Mechanical permits are issued, a Certificate of Insurance must be submitted in the amount of \$100,000 or the value of the structure being worked on, whichever is greater, for property damage and \$100,000/\$300,000 for bodily injury.




Section 4: Changes in Fee Schedule
