V. SUBDIVISION PLANS ACCEPTANCE AND ACKNOWLEDGEMENT

A map was given to the members to explain the layout of the property and asked if the members would support their efforts to try and get to the bottom of the issues with residents. Mr. Owens indicated he thought they might be addressing the incorrect board and suggested they present this to the Board of Supervisors. Ms. Fanning asked if the property was zoned for a sports facility. Mr. Abernathy indicated the zoning had changed and they were unaware of the change. Therefore they were working with the Zoning Hearing Board to get the changes made. Mr. Engleman explained that the Planning Commission would not be the correct Board to bring this issue in front Mr. Abernathy asked if there were any audience members that had complaints with regards to the soccer fields. Mr. Jerry Yeatman spoke as a land owner and stated that he had no problems with the soccer fields and supports the use of the fields. He was concerned with the cross traffic and the pedestrians crossing the street without looking. He would also like the lights to be in line with the ordinances that are in place for the township. He feels it is hard to see while driving with the lights on. Mr. Abernathy indicated that the parking and lighting situation would be reviewed and the issues would also be addressed with the Board of Supervisors and the Zoning & Hearing Board.
